Subject to availability, first come, first serve basis. **Tent rental fee must be paid at the time of registration.**

Two week minimum notice for reservation.

No paper streamers, confetti, balloons, gum, glass, or aluminum. Proper swim wear required. All facility rules and regulations apply.

In case of inclement weather or water quality issues, tent rentals may be rescheduled or a refund issued by check from the City of Stephenville. **Tent rentals are not available opening weekend or holiday.**

## **Tent Rental Agreement**

We ensure Splashville achieves its goals of providing clean, safe, and healthy facilities and a positive reservation/check-out experience. We have developed the following information on rules, terms and conditions for renting Splashville facilities. **The renter is responsible for 1) ensuring that all guests (swimming or non-swimming) are aware of and comply with all rules and regulations for the facility, including**

**but not limited to their admission into the park, 2) all food, drinks, and supplies not included in the rental agreement (no outside food or drink).** By signing the rental agreement, the renter states that they have read and agrees to abide by all conditions.

## **RENTAL PROCEDURES/POLICIES**

- a. **Reservations:** The renter must be 18 years or older. The renter, not designee, is required to sign the application. The total rental fees are due at the time of the reservation. Make all checks payable to: Splashville. Fingerprinting is required for payments by check.
- b. **Application Approval:** Splashville holds the right to deny any requests for good cause. An explanation will be given.
- c. **Cancellation:** The renter agrees to pay for all damages to any property of Splashville resulting directly or indirectly from the conduct of any member, guest or invitee. The renter also agrees they will hold Splashville harmless and indemnify Splashville from and against any and all liability, damages, and/or injury which may be imposed upon for any injury to persons or property caused by the renter or any other person in connection with renter's use of the facility named in this agreement. Renter assumes any and all risk associated with the use of Splashville facilities and equipment.
- d. **Admissions:** This agreement is solely for the rental of the agreed time at the assigned area. All admission fees must be paid following rental at the Splashville office with required quest list or upon entry to Splashville.

**RULES** All rules must be obeyed by the renter and any member, guest or invitee specified in the rental agreement. Failure to adhere to the rules and/or this agreement shall be considered a breach of contract and shall be penalized as prescribed below.

a. Any violation of the following or the facility rules may result in: 1) immediate termination of rental 2) forfeiture of fees 3) disqualification from future rentals, and if necessary, 4) police will be called. In addition any repeated and/or uncorrected Minor Violation may also be considered a Major Violation.

1. Facility staff **MUST** be respected and obeyed.
2. All pool rules will be enforced.
3. All persons and activities must comply with City, State, and Federal laws. This includes the prohibition of use and/or possession of weapons, liquor, tobacco products, and any illegal substances on the property.
4. Children under 10 years of age must be accompanied by an individual age 16 or older. A parent/guardian must be within arms-length of children who are unable to swim.
5. The use of open flames, "silly string", confetti, and fog machines are prohibited. Candles for cakes are allowed.

By signing, you agree that you have received, read, and understand all listed above and facility rules. Further, your signature attests that all information contained in this rental agreement is true and requested by you.
