What is the Environmental Collection Center?

- A drive-through, drop-off site for environmentally-safe and easy disposal of household hazardous waste.

Why use the ECC?

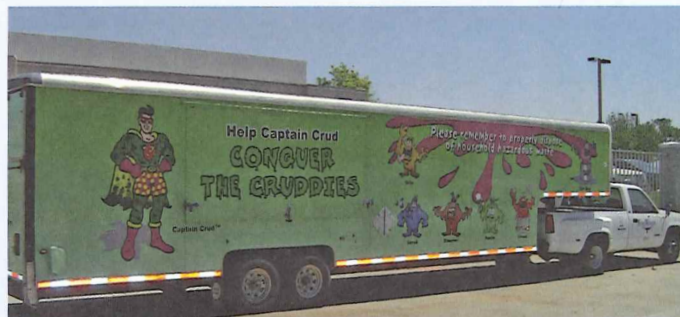
- Dumping household chemical waste into storm drains is illegal. Since stormwater enters streams, rivers, and lakes without any treatment, this may result in water pollution. This waste should not be disposed of in your home trash/recycling.

Who can use the ECC?

- Residents of Fort Worth and participating cities
- Proof of residency is required (driver's license OR current water bill)
- Residents of participating cities may need a voucher. Check with your local government or www.fortworthtexas.gov/env for voucher requirements.
- No commercial/industrial waste can be accepted.

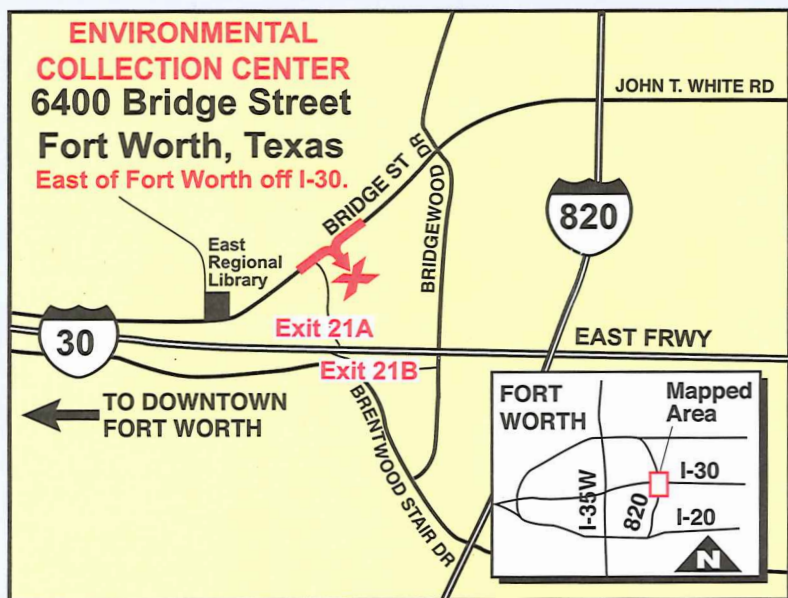
Crud Cruiser Mobile Collection Events

Transporting Your Waste

Keep chemicals in original, labeled containers. Place items in boxes or bins (no trash bags please) and secure in trunk or truck bed.



WHAT'S ACCEPTED?

Batteries, light bulbs, cooking oil, automotive fluids, cleaners and chemicals, paint and painting supplies, lawn/garden/pool chemicals

WHAT'S NOT ACCEPTED?

Asbestos/PCBs/radioactive items, ammunition, explosives, appliances, electronics, bulk trash, yard waste, butane and propane tanks, building materials, medicines and medical waste, used tires

¿Qué es el Centro de Colección Ambiental?

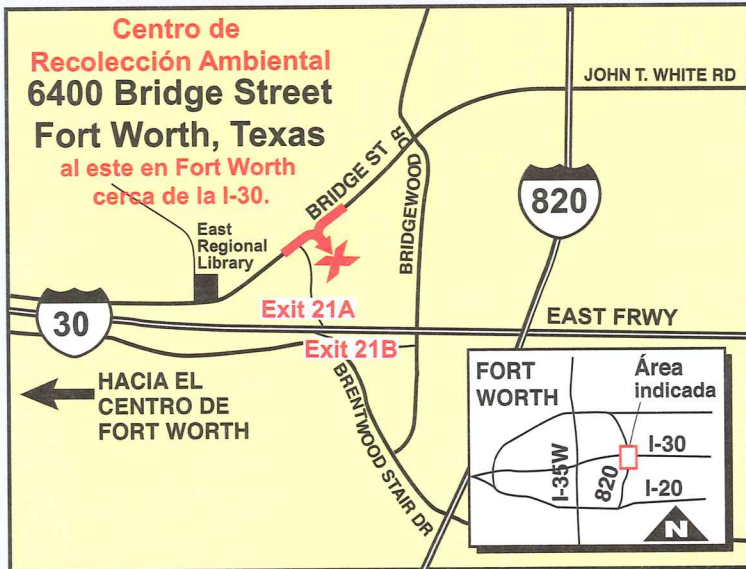
- Lugar en donde puede deshacerse de los químicos peligrosos.

¿Por qué debo utilizarlo?

- Deshacerse de químicos peligrosos a través del drenaje pluvial es ilegal, ya que los drenajes pluviales desembocan en los arroyos, ríos y lagos sin que el agua que acarrean sea tratada. Estos químicos tampoco deben tirarse en bote de basura de reciclado.

¿Quién puede utilizar el centro?

- Todo residente de Fort Worth y las demás ciudades participantes
- Se requiere comprobante de residencia (licencia de conducir o recibo del servicio de agua)
- Los residentes de las ciudades participantes pueden necesitar un vale. Verificar con su municipio o visitar www.fortworthtexas.gov/env para conocer los requisitos del vale.
- No se aceptan desperdicios comerciales/industriales.

Transportando los Desperdicios

Conserve los químicos en los envases originales y con la etiqueta. Coloque los artículos en cajas (no bolsas de basura) y asegúrelas en la cajuela o caja de su camioneta.

¿QUE SE ACEPTA?

Baterías, focos, aceite de cocinar, líquidos automotrices, limpiadores y químicos, pintura y materiales de pintura, químicos de jardín/piscinas

¿QUE NO SE ACEPTA?

Asbestos/PCBs/artículos radioactivos, munición, explosivos, aparatos, aparatos electrónicos, basura voluminosa y de jardín, tanques de gas butano y propano, materiales de construcción, medicamentos y basura médica, neumáticos
